The Richland County Community Alternative Center is pleased to announce we have received treatment certification from the **Ohio Department of Mental Health and Addiction Services**. This certification will allow our program to enhance our present programs with the inclusion of targeted treatment protocols.

We will now be able to also provide **Ohio Department of Mental Health and Addiction Services** approved **Alcohol/Drug Assessments** as part of the participants stay in our program. **The cost for the assessment is \$60.**

For **persons deemed to be in need of treatment services**, with our **Ohio Department of Mental Health and Addiction Services** certification, we will now provide:

- **Enhanced treatment programming** to include: Diagnostic Assessment, Group and Individual Therapy, Crisis Intervention, and Case Management Services.
- **Substance Abuse/Dependency treatment to include evidence-based/best practices programming:**
  1. Behavioral/Cognitive Skill Technique Utilization
  2. Brief Intervention and Brief Therapies for Substance Abusers
  3. Enhancing Motivation for Change (Motivation Interviewing techniques)
  4. Parenting Skills/Healthy Relationship Skill Development
  5. Life Skills Development
  6. Relapse Prevention Skill Development
- On-site/full-time Ohio Credentialing Board **Licensed Independent Chemical Dependency Counselor/Clinical Supervisor**. This staff member is also a Licensed Social Worker through the State of Ohio Counselor and Social Worker Board.

The program is designed for provision of services from 30-90+ days, with treatment tracks designed in Length of Stay Phases. We believe the increased specialization of the program; will be a primary indicator in enhancing positive outcomes.

**COST OF SERVICES:** For persons to participate in the OMHAS certified program:

1. **Diagnostic Assessment: \$60.** A diagnostic assessment **must** be completed prior to a client being able to participate in the counseling component of services per OMHAS standards.
2. **Treatment Program: \$50 per day.** This is inclusive of the treatment services and the residential component.

For persons in the Substance Abuse Program, an **Ohio Department of Mental Health and Addiction Services** Discharge Summary will be sent to referral sources/primary court system with approved Release of Information per the client. Ongoing case management services will be provided by the case managers and counseling staff.

**COST OF SERVICES:** For persons **NOT enrolled** in substance abuse **treatment** program: **\$40 per day.**

Persons in this program will be able to participate in educational programming including: Vocational Readiness, Changing Thinking Patterns, Drug/Alcohol educational classes, and Parenting Classes. Twelve-step recovery programs and pastoral programming will also be available to these clients.
