\$10.00 on moving violations in a criminal case for the Indigent Drivers Alcohol Treatment Fund pursuant to O.R.C. 2949.094,

\$25.00 for a Bond Surcharge Fee in a criminal case pursuant to O.R.C.2937.22(B),

\$20.00 to be used for computerization of the Clerk's office in each case or appeal and pay these funds to the County Treasurer to be disbursed only upon a court order pursuant to OR.C. 2303.201,

\$ 6.00 to be used by the General Division Court for computerized legal research and pay these funds to the County Treasurer to be disbursed only upon a court order pursuant to OR.C. 2303.201,

\$50.00 for Dispute Resolution (ADR) fees in each civil case filed in the general division and pursuant to Local Rule 2.02 and by Order of Court pursuant to O.R.C.1907.24

\$25.00 for Dispute Resolution (ADR) fees in each criminal case filed in the general division and pursuant to Local Rule 2.02 and by Order of Court pursuant to O.R.C.1907.24,

\$70.00 in each civil case for court special projects pursuant to O.R.C. 2303.201(E)(1),

\$25.00 in each criminal case for court special projects pursuant to O.R.C. 2303.201(E)(1), and
